#### **For EMX65-EMX85 SEMI FINALS**

All riders who want to take part in their semi-finals have to register for this race through the digital system. Riders can do this already together with the pre-round registration. (not taken into account the actual standings)

On Sunday evening after the last zone round the top 25 classified riders (who are registered for the semi-final) will already receive their confirmation.

On Monday evening after 18.00 Hrs the next riders in the classification of their respective zone (who are already registered) will receive their confirmation.

When at Tuesday 18.00 Hrs not 50 riders are registered, next riders in the classification, (irrespectively the zone and who are registered for the semi-final) will receive their confirmation. At Tuesday 23.00 hrs the list will be closed.

After this deadline the only change will be done when there is a rider deregistering for the race. Riders will always receive the conformation by mail address they presented at their registration.

The organizer disclaims all responsibility for damage to a motorcycle, its accessories and components arising out of an accident, fire or other incident.

## 13 - PROTEST AND APPEALS

---

Any person or group of persons (rider, entrant, manufacturer, official, etc.), recognized by the FIM and concerned by a decision taken under the authority of the FIM Europe, may ask for redress for the consequences of that decision.

Protest must be lodged according to the FIM Europe Disciplinary and Arbitration Code and the Supplementary Regulations and be accompanied by a fee of € 350,00 or equivalent amount in local currency, returnable if the protest is justified.

In general, protests against eligibility of a rider entered, must be made before the start of the official practice.

Protests against results must be presented to the International Jury within 30 minutes following the publishing of the results.

An appeal can be made to the FIM Europe Disciplinary Commission against a decision of the International Jury.

*In case of FIM combined races an appeal can be made to the FIM Stewards Panel against a decision of the Race Direction.*

Protest entailing a fuel control: See FIM Europe MX rules.

#### **14 - PRICE-GIVING CEREMONY**
